## **OPEN COMMENTS- VISITORS DISCUSSION**

Discussions of standardizing the size of the logo for each size of jersey to maintain consistency from year to year and also maintaining a standard for the one color logo. Jay confirmed that standardizing will save costs in the future.
- Travel first practice is 8/20. Jay would like all orders submitted by July 10<sup>th</sup>. Fitting day is scheduled for 5/30 5pm-9pm. If they are cannot make that they will need to stop to the proshop at their designated make-up night (assigned by team and communicated after 5/30).
- Discussions of how the electronic form will be done. Will a board member fill it out? Or the parent? Decided that parent will fill out the form and will receive a confirmation email. Link to form will be sent out to the teams by Teamsnap. We will have devices on hand for those that don't have them with them.
